1. MINIMUM REQUIREMENTS

- **1.1** For every person working on a TAQA operated sites, completing the training requirements below is mandatory.
- 1.2 Please find all minimum training requirements below. We kindly ask you to read them carefully and ensure all personnel working at a TAQA worksite has completed them.

2. REGISTRATION TAQA VENDORS PORTAL

Below are the instructions on how to create your own account via www.taqavendors.nl.

If you work for a TAQA vendor and require access to a TAQA operated site, the following steps are important:

- **a. Before you register:** Check the name of your contact person at TAQA. You need to fill in his/her name during the registration process. Only register yourself when you require access to one of the TAQA operated sites.
- b. Responsibility: each person is responsible for their own registration. As per April 1st 2024, the registration process will no longer be done by dedicated focal points within a vendor company.
- **c. Roles:** select your role according to the matrix on page 1.
- **d. Valid certificates:** If you have a certificate which is still valid, you can upload these in your account. The validity of the certificates is 2 years.
- e. VCA certificates: Please upload your valid VCA/VCA VOL/MIST certificate in your account.

Please click on the button below to go to TAQA Vendor Portal which enables you to get an overview of required training certifications based on your role and/or location that you will be working at. You can now start the registration process.

 - 2 Wrong answers are allowed, however, if 3 or more of your answers are incorrect you will have to take the test again. Once you successfully passed the test you will automatically obtain the certificate in your Training Portal. A copy will also be sent to your email address.
- 3.4 If you have not been on TAQA onshore sites before, please fill in the-badge-form and send it at least 2 days before your visit to the security officer (Security.nl@taqaglobal.com). You can manually upload your VCA/ MIST certificate in your account.
